Notes on 2018 Year End and 2019 Budget

As the total income and expense lines indicate, 2018 ended with Tsegyalgar East in good fiscal shape. Of particular importance in this regard was a reduction in payroll expenses in 2018 due to the Secretary role remaining unfilled for a substantial portion of the year.

The payroll expenses will continue to be lower in 2019, due to a realignment of bookkeeping and accounting responsibilities. John Shannon, who has done a wonderful job filling in for the vacant secretarial role in addition to his bookkeeping duties, will move from his previous bookkeeping duties to assume the role of Administrator instead, which is a new position that will be the prior Secretary position expanded to be a more integral part of the administration of the Gar. The bookkeeping duties will be taken on by Lowell Laporte, who is also working in that capacity for the Shang Shung Institute. The bookkeeper position will also subsume some of the work that Mike Leete/Ed Margola have been doing, but they will remain to do vital year-end accounting and Form 990 tax reporting. The result will be substantial savings on the bookkeeping/accounting side.

Also, Mike Leete, in his year-end profit and loss statement for 2018, has started new line items for Dzamlingar House income and expenses.

The Schoolhouse repairs and maintenance line item in the 2019 Budget column reflects the expense of installing the new boiler in the schoolhouse.

The furniture and equipment line item under general operating expenses reflects the purchase of new video equipment as the webcast of our programs takes on more and more importance. Blue has done a magnificent job of running our programs, increasing program income.
