Notes on 2019 YE P&L

- 1. The line items for Income / Donations include a \$30,000 donation, of which \$25,000 was for the Dzamlingar Gompa, and \$5,000 was for Tsegyalgar East. The \$25,000 for Dzamlingar Gompa is also recorded as a \$25,000 expense in the line item "Property Expenses / Dzamlingar House."
- 2. The \$14,000 expense of the new boiler in the Schoolhouse appears on the Balance Sheet, as the line item Land, Buildings & Equipment.
- 3. Our retreat income was more than double the amount earned in the previous year, an increase of nearly \$29,000.
- 4. In 2020, Tsegyalgar East applied for and received a loan from the Paycheck Protection Program (PPP), in the amount of \$4,782. This loan, part of the federal government's COVID-19 response, is forgivable, so it is tantamount to a federally-funded grant.
